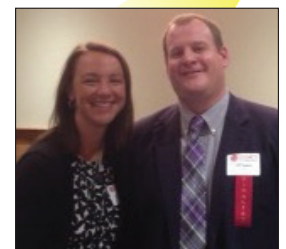
**Epplen Finalist 2015 Next Generation Leader**
